2011 WAIVER RELEASE & COVENANT NOT TO SUE / MEMBER INFORMATION FORM

Read Carefully Before Signing ≈ Applicant Must Provide All Information Requested Below

I, the undersigned, hereby certify and declare that I am participating in a dragon boat team and that in consideration of the use of any Seattle SAKE Dragon Boat Club (Club SAKE) dragon boat(s), whether the boat(s) are owned by Club SAKE or are being rented and under the care and control of Club SAKE, I personally and without reservation waive, release, acquit, and forever discharge Club SAKE, and any team captains, officers, agents, employees, Club members, the owner and manager of the premises at which the boat(s) are moored, and the United States Dragon Boat Federation (USDBF) from any and all suits, claims, demands, or assertions of liability of any nature whatsoever, for personal injuries, property damage, loss of services, injury to corporeal interests, or other like damages occasioned by, arising from, or otherwise connected with my participation in use of the dragon boats, and do personally covenant that no action of law or suit in equity shall ever be brought against Club SAKE, its team captains, officers, agents, employees, Club members, the owner and manager of the premises at which the boat(s) are moored or the USDBF, on account of any matter herein above set forth.

I declare that I am aware of the risks and hazards inherent in the sport of dragon boating and in the launching, docking and storing of equipment used in said sport. I further declare that I am aware of the risks and hazards in participating in dragon boat races and practices, that conditions may be hazardous and dangerous, that high winds may cause rough waters, that obstructions may exist, and that I voluntarily assume all risks of loss, damage or injury including death, that may be sustained by me or to any property while in or upon said dragon boat(s). I understand the necessity for supervision of my involvement on the dragon boat(s) and authorize Club SAKE, its team captains, officers, agents, employees and Club members who may be in charge from time to time to direct and control my activities where necessary for my protection and the protection of all participants on the dragon boat(s).

I further authorize Club SAKE, its team captains, officers, agents, employees and Club members to secure any reasonably necessary emergency medical aid for me and agree to pay for such aid and to hold Club SAKE, its team captains, officers, agents, employees and members harmless therefrom.

The provisions of this instrument shall be binding on my heirs, agents, successors and assigns.
